

MINUTES
UNION CITY BOROUGH WORK SESSION
FEBRUARY 25TH, 2014

The Work Session of the Union City Borough Council was called to order at 6:58 P.M. by Vice-President Braden McCrillis. The meeting was held at the City Building.

Councilors present were Conklin, Hoban, McCrillis and Steadman. Councilors Brumagin and Kolaja were absent.

Officials present were Borough Manager Cheryl Capela, Mayor Bob King, Police Chief Kevin Jones and Street Supervisor Paul Maynard.

There were no visitors present.

CONDITION OF STREETS: Street Supervisor Paul Maynard said Miles and Kilburn

Street is breaking up due to all the semi's going into Kwik-Fill. He said

another reason is due to water coming off of the corner property onto the road.

He said this is not the only street this is happening too. He said we need

to take a look at our Water Runoff Ordinance to see what it says about water runoff.

STREET SWEEPER: Street Supervisor Paul Maynard said he has some pictures

this evening in regards to the condition of the box on the street sweeper.

He said he wanted Borough Council to be aware of the condition of the street sweeper. He said sometime in the near future, we will have to consider buying a new street sweeper.

ANTI-SKID: Street Supervisor Paul Maynard said they have no place at the Borough Garage to store anti-skid. He said currently the anti-skid is being stored outside. He said with the cold weather, they have had to bring some of the anti-skid into the garage to get it unthawed. He said he along with the street crew have been clearing a place in the garage to store any future anti-skid that will be getting delivered.

STATE ROUTE SNOW REMOVAL: Street Supervisor Paul Maynard presented a summary to members of Borough Council on the amount of materials and time being spent on the state roads.

BULLET PROOF VESTS: Chief Jones said we received grant monies from the Union City Community Foundation to purchase the bulletproof vests for the Borough Police Officers.

He said that he and the Mayor will be presented with the check sometime in March.

LAW AND ORDER BANQUET: Chief Jones said the Law and Order Banquet will

be held on Saturday, March 15th, 2014 at 7:00 P.M. He said the speaker

for the evening is the newly elected Sheriff.

He said he will not be able to attend the Banquet. He said that he will

make sure to have an officer at this dinner.

DRUG EVENT TO BE HELD AT THE UNION CITY AREA HIGH SCHOOL: Chief Jones

Thursday, February 27th registration from 5:30 P.M. to 6:00 P.M.
