

MINUTES
UNION CITY BOROUGH COUNCIL
OCTOBER 13TH, 2015

The meeting of the Union City Borough Council was called to order at 7:00 P.M. by President Pro-Temp Daniel Hoban. The meeting was held at the Union City Area High School Large Group Instruction Room.

Councillors present were Conklin, Hoban, Kolaja and Steadman. Councillors Brumagin and McCrillis were absent.

Officials present were Borough Manager Cheryl Capela, Mayor Bob King, Police Chief David Pernice and Solicitor Timothy Wachter.

Visitors present were Howard Willie, Jack Bowersox, Roy Hanks and Sharon and Ahmed Syed.

APPROVAL OF AGENDA: It was moved by Councillor Conklin and seconded by Councillor Kolaja that the agenda stands approved as presented. Motion carried.

APPROVAL OF MINUTES: It was moved by Councillor Conklin and seconded by Councillor Kolaja that all Councillors having read the Work Session

held August 25th, 2015 Council Meeting held September 8th, 2015 and

the Work Session held September 27th, 2015, be approved.

Motion

carried.

MOTION ON SECRETARY'S REPORT: It was moved by Councillor Kolaja and

seconded by Councillor Steadman that the Secretary's Report be accepted

and made a part of the minutes of this meeting. Motion carried.

RESIDENT COMPLAINED ABOUT GARBAGE SERVICE: Howard Willie said

he lives at 63 Putnam Street said he used to put his grass clippings

and limbs over at the dump site on Bridge Street. He said since the

Borough decided to close the site, he has been putting his grass

clippings by the curb for the garbage service to pick up. He said

he has not had any problems in the past with them picking it up

until recently.

He said he noticed this past week that the garbage man looked at

it and decided it was too heavy for him to pick up and did not bother

to even try. He said he has been having problems with this issue for

the past couple of weeks.

President Pro-Temp Daniel Hoban said if you have any more problems,
give the information to the Borough Manager and she will take care of it for you.

Jack Bowersox said he also has problems with the garbage service not picking up his garbage.

MAYOR: Mayor Bob King said about two weeks now he has been getting on McDonalds to get their parking lot fixed. He said he is still waiting to see if it will get done.

MOTION TO APPROVE APPOINTING BETH MALEC TO THE PARKS AND RECREATION COMMISSION: It was moved by Councillor Kolaja and seconded by Councillor Steadman to approve appointing Beth Malec to the Parks and Recreation Commission to serve until December 31st, 2019.

MOTION TO ADOPT AN ORDINANCE AMENDING ORDINANCE NUMBER 1049, AS AMENDED, ENTITLED AN ORDINANCE OF THE BOROUGH OF UNION CITY, ERIE COUNTY, PENNSYLVANIA REGULATING THE PARKING OF VEHICLES UPON THE PUBLIC STREETS AND IN THE MUNICIPAL PARKING LOTS OF THE BOROUGH OF UNION CITY, ERIE COUNTY, PENNSYLVANIA, UNDER THE AUTHORITY OF THE PENNSYLVANIA LEGISLATURE, ACT OF APRIL 29TH, 1959 P.L. 58, AS AMENDED, PROVIDING FOR A DEFINITION OF PARKING ENFORCEMENT OFFICER (S) TO ENFORCE PARKING RESTRICTIONS; PROVIDING FOR SEVERABILITY AND FOR AN EFFECTIVE DATE: It was moved by Councillor

Steadman and seconded by

Councillor Conklin to approve the adoption of an Ordinance amending

Ordinance Number 1049, as amended, entitled an Ordinance of the

Borough of Union City, Erie County, Pennsylvania regulating the parking of

vehicles upon the public streets and in the municipal parking lots of the

Borough of Union City, Erie County, Pennsylvania, under the authority of

the Pennsylvania Legislature, Act of April 29th, 1959 P.L. 58, as amended,

providing for a definition of parking enforcement officer (s) to enforce

parking restrictions; providing for severability and for an effective date.

A roll call vote was taken. All Councillors voted yea. Motion carried.

COUNCIL TO APPROVE DEPOSITING THE GENERAL MUNICIPAL PENSION SYSTEM STATE AID IN THE NON-UNIFORM PENSION FUND: President Pro-Temp Daniel

Hoban said the Minimum Municipal Obligation for the 2015 Borough of

Union City Non-Uniform Pension Fund is \$18,010. He said the amount

of the General Municipal Pension System State Aid received from the

Commonwealth of Pennsylvania for the 2015 is \$18,732.94. He said he

needs approval from Borough Council to deposit the General Municipal

Pension System State Aid in the amount of \$18,732.94 into the Non-

Uniform Pension Fund.

MOTION TO APPROVE DEPOSITING THE GENERAL MUNICIPAL PENSION SYSTEM STATE AID IN THE AMOUNT OF \$18,732.94 INTO THE NON-UNIFORM PENSION FUND: It was moved by Councillor Kolaja and seconded by Councillor Steadman

to approve depositing the General Municipal Pension System State Aid in

the amount of \$18,732.94 into the Non-Uniform Pension Fund. Motion

carried.
