NOMINATIONS FOR PRESIDENT: Mayor Bob King opens the floor for nominations for

President of Borough Council to serve a two-year term.

Councillor Steadman nominates Braden McCrillis as President of Borough Council

and Councillor Conklin seconded the nomination. Motion carried.

MOTION TO CLOSE NOMINATIONS: It was moved by Councillor Brumagin and seconded

by Councillor Conklin that the nominations for President be closed. Motion carried.

MAYOR CALLS FOR A VOTE FOR THE OFFICE OF PRESIDENT: Mayor Bob King calls for a roll

call vote on the nomination of Braden McCrillis as President of Borough Council.

Councillors Brumagin, Conklin, McCrillis and Steadman voted yea. Motion carried.

Mayor Bob King said Braden McCrillis is now President of Borough Council.

NOMINATIONS FOR VICE-PRESIDENT: Mayor Bob King opens the floor for nominations

for Vice-President of Borough Council to serve a two-year term.

Councillor Steadman nominates Daniel Brumagin as Vice-President of Borough

Council and Councillor McCrillis seconded the nomination. Motion carried.

It was moved by Councillor McCrillis and seconded by Councillor Steadman

that the nominations for Vice-President be closed. Motion carried.

Mayor Bob King

calls for a roll call vote on the nominations of Daniel Brumagin as Vice-President

of Borough Council.

Councillor Brumagin, Conklin, McCrillis and Steadman voted yea. Motion carried.

Mayor Bob King said Daniel Brumagin is now Vice-President of Borough Council.

Pro-Tem. Motion carried.

Director of Public Safety appointed to Councillor Kolaja.

Director of Public Works appointed to Councillor Steadman.

Director of Parks and Recreation appointed to Councillor Conklin.

Director of Finance appointed to Councillor Brumagin.

Director of Personnel and Planning appointed to Councillor Hoban.

Brumagin and seconded by Councillor Conklin that the Borough Official's

expenses and/or employees be paid by the Borough when said officials and/or

employees attend any function related to their duties or make any trips which

allowance and all other expenses will require approval from Borough Council.
