**APPROVAL OF AGENDA:** It was moved by Councilor Kolaja and seconded by Councilor Hoban

that the agenda stands approved as presented. Motion carried unanimously.

**MOTION ON MINUTES**: It was moved by Councilor McGuire and seconded by Councilor Kolaja

that all Councilors having read the minutes from the council meeting on November 13, 2018 and the Special Work Session on November 19, 2018 be approved. Motion carried unanimously.

Councilor Hoban and seconded by Councilor Kolaja to approve paying 2018 employee bonus' as specified. Motion carried unanimously.

**PUBLIC SAFETY**: The Director of Public Safety was not in attendance at this time.

**PARKS AND RECREATION**: The Director of Parks and Recreation had no report or

Recommendations. Mayor Wilmoth stated there was over 200 people in attendance for

the Cookies with Santa event. They had horse drawn wagon rides that was well liked.

**STREET SUPERVISOR - BOB PHILLIPS:** There is a sewer problem on Putnam Street where the

water is not draining. Great Lakes is coming possibly Thursday to clean it out. They will use the camera's when the water drains out.

**<u>PUBLIC WORKS</u>**: The Director of Public Works had no reports or recommendations.

**PERSONNEL AND PLANNING**: The Director of Personnel and Planning had no reports or

MOTION TO SUBMIT THE POLICE CONTRACT TO THE POLICE BARGAINING UNIT BASED ON VERIFICATION FROM COUNCILOR BRUMAGIN AND MAYOR WILMOTH THAT THE PROPOSAL AND CORRECTIONS HAVE BEEN MADE AND ARE CORRECT. It was moved by Councilor

McGuire and seconded by Councilor Hoban to submit the police contract to the police bargaining unit based on verification from Councilor Brumagin and Mayor Wilmoth that the proposal and corrections have been made and are correct. Motion carried unanimously.

## MOTION TO MAKE NECESSARY CORRECTIONS ON THE POLICE CHIEF'S CONTRACT AND PRESENT IT TO CHIEF PERNICE. It was moved by Councilor Steadman and seconded by

Councilor McGuire to make necessary corrections on the Police Chief's contract and present it to Chief Pernice. Motion carried unanimously.

**2019 BUDGET:** Because of the large deficit the Borough is facing Council is expecting

employees and supervisors to work to control costs and keep expenses down. Any short fall bill be from the Capital Improvement account.

MOTION TO ADVERTISE THE PROPOSED BUDGET AND COUNCIL VOTE ON THE FINAL BUDGET AT THE DECEMBER 11, 2018 MEETING. It was moved by Councilor Hoban and seconded by

Councilor McGuire to advertise the proposed budget and Council vote on the final budget at the December 11, 2018 meeting. Motion carried unanimously.

**ADJOURNMENT**: It was moved by Councilor Hoban and seconded by Councilor McGuire that

the meeting be adjourned. Motion carried unanimously.
