Engineering for TA Set-Aside Grant - \$87,000 (UCCF GRANT & ARPA & GAP)

Route 97 Storm Water - \$400,000 (ARPA & GAP) — Engineering plans are in place, may need some alterations. This is estimated to cost approximately \$400,000.

Pleasant Street & Willow Street Bridges – Erie County at-risk bridge grant funding would provide 60%

Storm Water Sixth Avenue – Engineering?

Miles Street – Installing catch basins & pipes
