**PARKING ORDINANCE:** Review the proposed parking ordinance.

MOTION TO APPROVE ADVERTISING THE PROPOSED AMENDMENT TO THE PARKING ORDINANCE AND CHANGE THE OVERNIGHT PARKING IN BOTH MUNICIPAL LOTS 1 AND 2 AND THE ADDITION OF MUNICIPAL LOTS TO SECTION 7 (a)1(x). Motion made by Councilor Brumagin and seconded by Councilor Joyce. Motion carried unanimously.
