MINUTES UNION CITY BOROUGH APRIL 25, 2023

VISION STATEMENT: "The Union City area is a thriving rural community of families, businesses and organizations dedicated to encouraging growth while maintaining small town values."

The Council Meeting for the Borough of Union City was called to order at 6:00 P.M. by Councilor Joyce. The meeting was at the First United Methodist Church, 42 East High Street, Union City. The meeting opened with the Pledge of Allegiance and a moment of silence.

- **COUNCILORS PRESENT** were Joyce, Winkler, Osborn, and Steadman. Cross, Warner, and Daggett were absent.
- **OFFICIALS PRESENT** were Mayor, Natalie Wilmoth; Borough Manager, Cindy Wells; Police Chief, David Pernice; and Streets Supervisor, Bob Phillips.
- **APPROVAL OF AGENDA:** Motion made by Councilor Winkler and seconded by Councilor Osborn to adopt the agenda as amended by adding the consideration of a motion for a purchase of a vacant lot from the Erie County Landbank and the executive session to include discussion on a performance bond. Motion carried unanimously.
- **MOTION ON MINUTES:** Motion Made by Councilor Winkler and seconded by Councilor Osborn that all Councilors, having read the minutes, approve the Council Meeting on April 11, 2023. Motion carried unanimously.

HEARING OF THE VISITORS: No visitors wanted to speak.

POLICE CHIEF: The Police Chief reported that he gave two school tours of the Police Department from students at Early Connections.

The hood on the 2016 Intercepter has been repaired.

He finished filings on the PCCD grant and he has ordered the TRACS equipment. At some point the tasers need replaced.

PUBLIC WORKS: The Street Supervisor reported that the paving project for Route 97, Main Street and East High Street was awarded by PennDOT to Lindy paving. There is a 24" storm pipe from Country Fair to approximately the old Serrins Store building. PennDOT wanted the Borough to camera the line and clean all the catch basins on these streets so they could determine which ones needed to be replaced. When Mansfield used the camera on the 24" pipe a large rock was found to be blocking the pipe. PennDOT already planned to replace nine catch basins. Bob stated that about 80% of the catch basins need replaced on Main and East High. PennDOT will look at them. Fifth Avenue storm pipe and catch basin was installed and they are waiting on cement to rebuild the second catch basin.

MAYOR: The Mayor reported that the Historical Society was having an open house on May 6,

2023 from 10:00 -5:00. There have been several improvements completed in the Museum.

MOTION TO APPROVE THE APPLICATION SUMBITED TO ERIE COUNTY LAND BANK FROM ANGELA REICHBAUM TO PURCHASE 46 ATLANTIC STREET, CONTINGENT ON THE FACT THAT THERE WILL BE A COMBINATION DEED WITH 56 ATLANTIC STREET AND A 24' X 24' GARAGE CONSTRUCTED WITHIN THE NEXT 12 MONTHS, CONTINGENT UPON THE ACCEPTANCE OF THE APPLICATION BY THE ERIE COUNTY LAND BANK. Motion by Councilor Osborn and seconded by Councilor Steadman. Motion carried unanimously.

BENTLEY RUN EMERGENCY PERMIT FOR STREAMBANK STABILIZATION WORK: The emergency permit was received. GPI recommends modified mud sill cribbing which would be a permanent fix. Would need approval from DEP. One estimate was approximately \$17,000.

MOTION TO APPROVE OBTAINING THREE TELEPHONE QUOTES USING THE SCOPE OF WORK FROM GPI. Motion by Councilor Winkler and seconded by Councilor Osborn. Motion carried unanimously.
