When you submit your application, you need to do the following:

- 1. Return the completed police officer employment packet to the police station or by email at secretary@ucpolice.us.
- 2. Provide proof of Act 120 Certification.
- 3. For veterans of the United States Armed Forces, provide proof of honorable military discharge or documentation of current military status.
- 4. Provide a copy of your driver's license.
- 5. Provide a copy of your original Social Security card.
- 6. Provide a copy of your birth certificate. (If you do not have a birth certificate, you can obtain one from the Health Department of Vital Records.)
- 7. If your application is submitted in person, make sure that the person you turn your application into time stamps your application.

JOB DESCRIPTION FOR POLICE OFFICER

GENERAL DEFINITION

A police officer in the Borough of Union City will perform general duty police work in the protection of life and property throughout the municipality, prevent violations of statues and ordinances, investigate and suppress disturbances, and investigate complaints. They will be expected to work various shifts to include nights, weekends and holidays.

The work of a police officer consists of varied police assignments. They conduct investigations as directed by a superior officer, perform routine preliminary investigations, and miscellaneous duties, all performed in accordance with departmental rules and regulations. A senior officer regularly checks and evaluates performance. A police officer is required and expected to exercise initiative discretion and good judgment during the performance of required duties.

TYPICAL EXAMPLES OF WORK

- Enforce state and local laws and regulations
- Patrols as assigned during work shifts
- Checks doors and windows, and examines premises of unoccupied buildings or residences in order to detect suspicious conditions
- Investigates suspicious conditions and complaints and makes arrests on persons who violate laws and ordinances
- Accompanies prisoners to headquarters or court and appears in court as arresting officer
- Directs traffic and either arrests or gives citations to those who break traffic laws
- Investigates accidents as required by law and department regulations and prepares the necessary reports
- Maintains order in crowds and attends parades and other public gatherings as directed
- Makes investigations and enforces state and local laws pertaining to juvenile offenders
- Answers all complaints and takes necessary corrective action
- Give advice on laws and ordinances and general information to the public
- Operates patrol car as required
- Transport prisoners as required
- Assist motorists whose vehicle are broken down or stranded
- Perform all other work as required

UNION CITY POLICE DEPARTMENT DISQUALIFYING FACTORS

Effective March 4, 2024, the Union City Police Department has updated its hiring standards. The new standards are as follows:

I. <u>Criminal Convictions</u>

The following convictions disqualify an applicant from employment with the UCPD:

- Any offense which would prohibit the applicant from possessing a firearm or obtaining employment as a law enforcement officer at the time of application for employment with the UCPD; and
- b. Any other felony or misdemeanor which reflects negatively on the applicant's suitability for employment with the UCPD.

II. Traffic Record

- a. An applicant's driving record will be considered on a case-by-case basis with the past 5 years being the most critical.
- b. The following will be considered automatic disqualifiers if such convictions occurred within 5 years of applying: DUI, negligent or reckless driving, or misdemeanor hit and run.

III. Drug Use

- a. For the purposes of this section, any applicant may be rejected on the basis of current illegal drug use and/or discharge from employment as a law enforcement officer on the basis of illegal drug use.
- b. The drugs listed in this section are for reference and may not include all drugs or categories of drugs for the purposes of this section.
- c. Use of the following drugs shall not occur within 5 years of applying:
 - i. Depressants such as but not limited to: heroin.
 - ii. Sedative drugs such as but not limited to: ketamine, ghb, rohypnol (date rape).
 - iii. Hallucinogens such as but not limited to: psilocybin (mushrooms), pcp, angel dust, wet, phencyclidine, or lsd.
 - iv. Stimulants such as but not limited to: Cocaine, Crack cocaine, Ecstasy, methamphetamine, crank, glass, ice, speed, amphetamines, or khat.
- d. Marijuana use shall not occur within 1 year of applying.

IV. If the Applicant is Disqualified

- a. Any applicant who believes that they are aggrieved by the actions of the Commission, in refusing to examine or certify them as eligible after examination, may request a hearing before the Commission pursuant to Section 3.9 of the Rules and Regulations for the Civil Service Commission of the Borough of Union City.
- b. If the applicant is disqualified, the applicant must wait 3 years to reapply.
- c. Falsification of information may result in a permanent disqualification.

V. If the Applicant is Not Disqualified

- a. All successful candidates will be subject to a 1-year probationary period.
- Lying, falsification, misrepresentation or omission of any information that is required or requested by the UCPD to conduct an intense background investigation will be grounds for disqualification.
